Due to the national and state public health emergency regarding Coronavirus Disease 2019 (COVID-19), and in accordance with the March 16, 2020 "The President's Coronavirus Guidance for America," the Tucson Indian Center (TIC) will modify or cancel all events and activities of 10 or more people through April 10, 2020 or later.
